### Key Things to Remember

- WLSD has a groundwater disposal permit
- Operating under a Consent Order for 22 years
- DEEP sets conditions for our operation
- DEEP has ultimate authority for permits
- DEEP: Fix problem or go to Torrington



#### Facilities Plan Update - Scope of Work

- Approved by DEEP February 3, 2011
- Work commenced in March
- Early focus concentrated on:
  - Collection System Inflow & Infiltration
  - Groundwater Disposal System



### **Collection System -Inflow & Infiltration**

- Work accomplished to date:
  - Reviewed historical flow data
  - Flow isolation on 4.2 miles of sewer line
  - 80% of manholes inspected
  - CCTV inspections of 2.5 miles of sewer line
  - 200 houses inspected.



## Collection System -Inflow & Infiltration

- I&I findings and potential removals so far:
  - 26,000 gpd infiltration in sewer line
  - 30-50,000 gpd in leaking manholes
- Phased Plan for additional work
  - Complete manhole inspections repair problems
  - External inspections of roof drains, cleanouts, chambers
  - Smoke Test and dye test suspected problem areas
  - Work with homeowners to repair problems
  - Inspect cross-country areas for "larger sources"

## Groundwater Disposal System

- Fields cleaned up and valves repaired
- Preliminary groundwater tests ran in May
- A number of beds showed good absorption
- Proposed final groundwater tests
  Technical discussions with DEE



- Key requirements for WLSD in tests:
  - Clearly defined parameters and metrics in advance
  - Consistent application of guidelines & regulations
  - Not held to higher standards than other WPCAs
  - Relief or sharing of additional costs





## Other Scope of Work Tasks

- Define Service Area, Flows, etc.
- Collection System SCADA
- Treatment Facility Evaluation
- Regionalization Alternatives (Torrington)





# Where are we with DEEP?

- Working to develop technical standards for Disposal System Testing
- DEEP to delay field tests until March/April 2012





# Legal & Legislative

- Formed search committee to retain legal counsel
- 3 law firms selected for interviews
- Hartford based Shipman & Goodwin chosen
- Provide strategy, environmental, and regulatory advice to deal with DEEP
- Consider best approach for legislative support



#### **Financial Matters**

- Scope of Work (Budget of \$563,000)
  - Spent approx. \$200,000 to date
  - Roughly on budget
- No new estimates on long term costs



# What Happens Next?

- Scope of Work activity:
  - Continue I&I work
  - Reach agreement with DEEP on tests
  - Split remaining work between 2011 & 2012
- Legal and legislative activity:
  - Consider strategy with DEEP, etc.
- Financial matters:
  - Explore options, assessments, etc.
